Appendix 1

DATA PROTECTION NOTICE

Eleventh Hour Films Limited ("Eleventh Hour Film") is the controller of your personal data.

This notice explains:

- Why Eleventh Hour Films processes your personal data;
- With whom Eleventh Hour Film shares your personal data;
- How Eleventh Hour Films protects your personal data if it is transferred outside the European Economic Area;
- Your rights; and
- Who to contact if you have queries.

Why does Eleventh Hour Film process your personal data?

Personal data which you supply throughout the casting process to Eleventh Hour Films about yourself (including but not limited to information about your health and any previous criminal convictions) will be used in a number of ways, for example:

- 1. Where it is necessary for Eleventh Hour Film's legitimate interests, as listed below, and where the Eleventh Hour Film's interests are not overridden by your data protection rights:
 - for selecting potential contributors to take part in and appear on the relevant television series ("the Programme").
 - to assess whether you are a suitable contributor in relation to the Programme
 - to safeguard your welfare during participation in the Programme
- 2. Where this is necessary for Eleventh Hour Films to establish or perform the contract between you and the Eleventh Hour Films:
 - to develop, produce and publicise the Programme and
 - (if you are selected to participate in the Programme) to broadcast and distribute the Programme and exploit all allied and ancillary rights including but not limited to video, DVD, online, books and magazines.
- 3. Where you have given your consent to the processing of your personal data: to send you
 - direct marketing from Eleventh Hour Films
 - to carry out background checks (including criminal record checks).
- 4. We also carry out background checks on the internet and social media, to assess whether you are suitable for the Programme. We may also use a third-party database that combines private and public information, to conduct our background searches. This is in our legitimate interest to assess whether you are suitable for the Programme.
- 5. When Eleventh Hour Films asks you for personal data, Eleventh Hour Films will make clear which personal data has to be provided by law, or in order for Eleventh Hour Films to enter into or fulfil a contract with you. If mandatory data is not provided, then Eleventh Hour Films will not be able to assess your application to participate in the Programme.
- 6. Eleventh Hour Films will retain personal data no longer than is necessary to carry out the purposes listed in this notice and/or as required by applicable law.

With whom does Eleventh Hour Films share your personal data?

- 7. Eleventh Hour Films will not publish your address or contact details.
- 8. Your personal data will be shared with: members of the Programme production team and relevant staff at the broadcaster of the Programme;

Eleventh Hour Film's insurers as well as the broadcaster's insurers, where deemed necessary; and third parties who provide services to Eleventh Hour Films in connection with:

- > suppling IT systems and services
- > marketing and social media support
- > administering compensation and travel reimbursements

Information about transfer of personal data

9. Should we transfer your personal data outside of the European Economic Area to a country that does not have data protection legislation that does not afford the same level of protection as within the European Economic Area, Eleventh Hour Films puts in place transfer mechanisms approved by the European Commission, including use of approved contractual clauses, Privacy Shield and Binding Corporate Rules.

Your Rights
